Any applications where face masks are subjected to re-use and require on site disinfection may be suitable for INSTRUMAX<sup>®</sup> PINK.

DIRECTIONS FOR USE:

#### Environmental surfaces and non-critical medical devices

1. Remove organic soiling (blood, sweat, sputum etc) from the surface or device. For surfaces use a detergent (i.e. Speedy Clean or Mediclean) and for devices use an instrument detergent (i.e. Matrix®, Clinimax®, Sonidet) according to the equipment manufacturers instructions.

• Klebsiella pneumoniae (CPE/CRE)

• Staphylococcus aureus (MRSA or Golden Staph)

• Pseudomonas aeruginosa

2. FOR DISINFECTION: USE UNDILUTED

Disinfect the surface using Instrumax<sup>®</sup> Pink ensuring the product fully contacts the surface or device. Allow to dry, ensuring a minimum 10-minute drying time. Instrumax<sup>®</sup> Pink can be used to soak devices directly in the solution for not less than 10 minutes.

Non-critical medical devices should be rinsed with potable water and allowed to dry.

If soaking instruments in Instrumax<sup>®</sup> Pink all solutions should be discarded within 8 hours of decanting from the original container, or immediately if the solution becomes visibly contaminated.

Correct PPE, including suitable gloves, should be worn when handling and using all disinfectant products. Not for use on skin.

Discontinue use if irritation occurs. Store below 30C out of direct sunlight. Do not mix with detergents or other chemicals. Non-hazardous as designated by Safe Work Australia guidelines.

\* 10-minute contact time is essential for thorough disinfection.

#### FOR DECONTAMINATION OF DENTAL IMPRESSIONS:

- 1. Rinse impression for 20 seconds with cold tap water.
- 2. Soak impression for 60 seconds in Matrix at a 10mL/L dilution in tap water.
- 3. Rinse impression using cold tap water. Shake to remove excess water.
- 4. Soak impression for 10 minutes in a tray containing 1L of Instrumax Pink.
- 5. Rinse impression using cold tap water and allow to dry.

The INSTRUMAX<sup>®</sup> PINK solution must be discarded after being used to decontaminate 12 impressions, or 4 hours or when the solution becomes visibly contaminated (whichever occurs first).

INSTRUMAX® PINK is not intended to be used on semi-critical or critical medical devices.

Note: INSTRUMAX<sup>®</sup> PINK can be used for both the cleaning and disinfection steps (i.e. Instrumax<sup>®</sup> Pink has been shown to effectively remove soil as a detergent).

Environmental surfaces or instruments other than medical devices should be treated in the same way as non-critical medical devices. INSTRUMAX® PINK is intended only for the disinfection of environmental surfaces and non-critical medical devices and should not be used for the disinfection of any critical medical device.
