Eliminate all sources of ignition. Ventilate area thoroughly and wear a suitable respirator if necessary to minimise inhalation. Wear suitable personal protective equipment such as protective gloves to prevent skin contact.

Spills / Clean up

Eliminate all sources of ignition. Ventilate area thoroughly and wear a suitable respirator to minimize inhalation. Clean up personnel should wear full protective clothing. Stop leak if safe to do so. Prevent spill entering waterways.

For larger spills (greater than 1L) – contain spill by placing inert, non-combustible absorbent material such as toweling, vermiculite, sand or dirt onto spill.

For small spills (less than 1L) – can be wiped up using clean rags. Collect material using non-sparking tools and place into a suitable container for disposal according to local regulations. Clean area by working from the periphery to the centre of spill or from the edge of the room to the centre.
